Liquid and Solid waste disposable systems in College:

Solid waste which includes left over from canteen and hostel kitchens. Garden waste are collected and transported to the waste disposable sites by Garbage trucks facility provided by the NMC. The solid waste is transported through the NMC transport. On other hand, the hazardous waste from hospital that are called as Bio Medical waste which includes non-liquid tissues, body parts, blood, blood products and others like laboratory/veterinary waste are handled and disposed by M/s. SMS Water grace BMW Pvt. Ltd., Nashik in conjunction with MPCB Sub- Regional office, Health Officer NMC, Nashik. The college campus is always kept neat & cleans by the sweeper working throughout the day continuously.

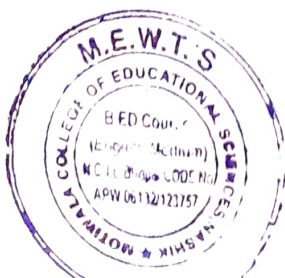
E-Material waste disposable systems in College:

Second priority shall be given to employees of the college and the hospital. The other option is to sell it in the market, still if no response is received; it is forwarded for scarping through proper way. All E Material waste details are maintained in a file or register including the type of disposal.

1. Purpose

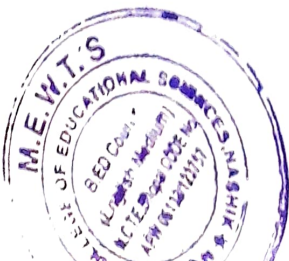

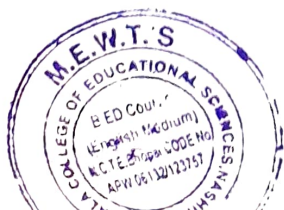
